### 386650 NO BAKE SLICE CHOC SG - 12.5Kg

#### TYPE

A premix to which melted butter/margarine is added for production of a no bake slice.

#### USAGE

2.000kg No Bake Choc Slice  
0.380kg Melted butter or marg  
0.180kg Water

Add no bake choc slice and water into bowl with beater  
Mix for 1 min on slow speed, Add meted butter or marg  
Mix for 1 min on slow speed. Scrape down  
Mix on slow speed for approx 2 mins  
Press firmly into an ungreased baking tray  
Place in fridge until set (approx 90 mins). Finish as required
